Acknowledgement of Risks

I, the undersigned, acknowledge and fully understand that the use of inflatable bounce castles involves inherent risks, including but not limited to: falls, collisions, slips, trips, improper use, or other accidents that could result in injury. I voluntarily assume all risks associated with the use of the equipment provided by **CEA Events**.

Release of Liability

In consideration of renting and using the bounce castle(s) and related equipment, I hereby release, discharge, and hold harmless **CEA Events**, its owners, employees, and agents, from any and all claims, demands, damages, or causes of action, whether known or unknown, arising out of or related to any injury, loss, or damage that may occur during the use of the rental equipment.

Safety Rules & Responsibilities

I agree to follow all **rules and safety instructions provided by CEA Events**, including but not limited to:

- Adult supervision is required at all times while equipment is in use
- **No food, drinks, gum, candy, or pets are allowed inside or on the inflatable.**
- No shoes or sharp objects allowed inside.
- No flips, wrestling, or rough play.
- Maximum occupancy and weight limits must be observed.
- Equipment must not be moved, deflated, or altered in any way.
- No smoking or barbeques on or around the inflatable.

I Understand that failure to follow these rules may result in injury and/or additional fees for damages.

Cleaning and Damage Fees

I understand and agree that if food, drinks, or other prohibited items are spilled, left, or used inside/on the inflatable, a **mandatory \$50.00 cleaning fee** will be charged.

I also agree to pay for any damage to the equipment beyond normal wear and tear.

Security Deposit

A refundable security deposit may be required at the time of rental. This deposit will be returned in full once the equipment is inspected and confirmed to be in proper condition, free of damage and excessive cleaning needs.
